The U.K. based Times Higher Education (THE), the publisher of widely-referenced university rankings worldwide announced the World University Rankings in the field of Business and Economics. Only EMU from the Turkish Republic of Northern Cyprus (TRNC) and 11 universities from Turkey have appeared in the ranking, in which a total of 795 universities have been included. EMU Business and Economics Faculty, which appeared in the 401-500 band last year, increased its success this year and has appeared amongst the world's top 250 Business and Economics Faculties, whilst sharing the first place with Koç University in Turkey in the 201-250 band. Bilkent University, METU,

Sabancı University and Yıldız Technical University, which succeeded in being listed among Turkish universities, have appeared in the 401-500 band and thus, come second. Boğaziçi University, Dokuz Eylül University, Hacettepe University, Istanbul University and Marmara University shared the third place in the 601+ band. Three universities in total made it to the list across the island of Cyprus, while EMU has appeared in the top band among these universities. Among the said universities, the second ranked university is in the 501-600 band.

#### EMU BUSINESS AND ECONOMICS FACULTY'S MASTER'S PROGRAMS ARE AMONGST THE BEST




Three postgraduate programs of the Eastern Mediterranean University (EMU) Faculty of Business and Economics have been included in the top 200 postgraduate programs list in the 2021 report prepared by Eduniversal, a ranking agency that evaluates postgraduate programs at a global level. EMU Business and Economics Faculty Dean Prof. Dr. Selcan Timur stated that Eduniversal has carried out its assessment by examining more than 22,000 programs of nearly 4,000 institutions from 154 countries and dividing the universities into 9 regions. Prof. Dr. Timur said, "In the 2021 evaluation, the Energy Economics and Finance master's program, which is the joint master program of the Economics and Banking and Finance Departments, has been ranked 5th in the Eurasia and Middle East region in the field of Energy and Natural Resources; Banking and Finance master's program has been ranked 10th in the Eurasia and Middle East region in the field of Corporate Finance and 10th in Eurasia and Middle East in the field of Economics".





## EMU APPEARS IN SHANGAI LIST ONCE AGAIN IN THE FIELD OF ECONOMICS



Eastern Mediterranean University (EMU) has once again been included in the field of Economics in the Global Ranking of Academic Subjects list of China-based Shanghai Ranking's Academic Ranking of World Universities 2021.

Shanghai Ranking has been publishing world university rankings since 2009.

EMU is the only university from the island of Cyprus to have been listed in ShanghaiRanking's Economics category.

In the said ranking, Koç University and Bilkent University were the universities of Turkey to have appeared in the ranking. While EMU and Bilkent University are in the 401-500 band, Koç University appeared in the 201-300 band. Making a statement on the subject, EMU Business and Economics Faculty Dean Prof. Dr. Selcan Timur congratulated the Chair of the Department of Economics Prof. Dr. Mehmet Balcılar and all academic staff contributing to the Department's success.

## EMU BUSINESS AND ECONOMICS FACULTY'S FIBAA ACCREDITATION WAS RENEWED







Eastern Mediterranean University (EMU) Business and Economics Faculty was granted unconditional accreditation effective until 2026 by successfully completing the accreditation process operated by one of the most distinguished accreditation institutions all around the world, The Foundation for International Business Administration Accreditation (FIBAA).

By stating that EMU Business and Economics Faculty was the first faculty to be granted the FIBAA accreditation, EMU Business and Economics Faculty Dean Prof. Dr. Selcan Timur emphasized the pioneering role of EMU in this regard. Expressing that the FIBAA accreditation they received for the first time in 2014 is extremely important in terms of showing

the quality of the programs within the Faculty, Prof. Dr. Timur underlined that the quality education provided in 17 undergraduate, 25 graduate (with / without thesis) and 4 doctoral programs within the Faculty is at world standards.

## EMU BUSINESS AND ECONOMICS FACULTY WAS GRANTED WITH ACTIVE MEMBERSHIP IN PRME

## PRIME Principles for Responsible Management Education

an initiative of the United Nations Global Compact

Eastern Mediterranean University (EMU), Business and Economics Faculty has been granted the "active member" status following presenting its first progress report in United Nations Principles for Responsible Management Education platform. EMU was initially joined the platform back in 2019.

EMU Faculty of Business and Economics Dean Prof. Dr. Selcan Timur stated that PRME, supported by the United Nations (UN) and established on the basis of the United Nations Global Compact, has 6 basic and founding principles, and said that these principles are based on the progress of corporate sustainability and social responsibility efforts. Working with six basic principles, PRME aims to raise the sustainability profile in universities around the world and to provide future managers with the knowledge and skills related to these principles.

While drawing attention to the Sustainable Development Goals (SDGs), PRME aims to align academic insti-

tutions with the UN Global Compact. SDG is a universal call to action to eradicate poverty, protect our planet and ensure that all people live in peace and prosperity. It aims to provide the necessary skills (corporate sustainability, adherence to ethical values that take into account all stakeholder groups in the decision-making process, etc.) while raising future leaders and managers as Responsible Managers for the realization of the SDG.

Prof. Dr. Timur made the following statements regarding the matter; "In our Progress Report given to PRME, we have included our work within the framework of these 6 principles. As we have shown in this report, the departments in our Faculty will contribute to our students and stakeholders' understanding of the importance of social and corporate sustainability, social responsibility and environmental protection, and will carry out activities to establish educational and developmental systems."

## EMU BUSINESS AND ECONOMICS FACULTY MEMBERS LISTED AMONG WORLD'S MOST SUCCESSFUL SCIENTISTS

12 academic staff members from Eastern Mediterranean University (EMU) showed success by being listed among the world's most cited 100 thousand and 160 thousand scientists within the scope of the "World's Most Influential Scientists" list which is compiled by a team of scientists from USA and Holland during 2019 and 2020 under the coordinatorship of Stanford University in USA. The comprehensive research conducted by Stanford University in 2020 included 6 scientists from EMU who achieved to be listed within the first 2 percentile of their categories.

According to the report, the list includes 160,000 scientists who have the most influential effects all around the world. Eastern Mediterranean University (EMU) Business and Economics Faculty academic staff members Prof. Dr. Salih Katırcıoğlu and Prof. Dr. Mehmet Balcılar are listed among the world's most influential scientists. Within the scope of the study which is conducted by USA Stanford University and published in PlosBiology Journal, Business and Eco-

nomics Faculty, Department of Banking and Finance academic staff member Prof. Dr. Salih Katırcıoğlu appeared among the world's most influential scientists list in categories of One Year Effect (2019) and Throughout Career Effect within the 2% segment.

Business and Economics Faculty, Department of Economics Chair Prof. Dr. Mehmet Balcılar also appeared in the 2% segment in One Year Effect (2019) category of the list featuring world's most influential scientists. EMU Business and Economics Faculty Dean Prof. Dr. Selcan Timur made a statement on the matter and congratulated Prof. Dr. Salih Katırcıoğlu and Prof. Dr. Mehmet Balcılar for their success. Apart from stating that the Business and Economics Faculty members always providing good quality education, academic staff also have publications in top-ranking scientific journals.

EMU members Prof. Dr. Salih Katırcıoğlu, Prof. Dr. Osman M. Karatepe, Prof. Dr. Nazım I. Mahmudov, Prof. Dr. Hasan Kömürcügil, Prof. Dr. Osman Kükrer and Prof.

Dr. Benedek Nagy are listed among the most influential scientists. Moreover, each EMU academic staff member achieved to be listed in the first 2 percentile of their field of studies; Prof. Dr. Salih Katırcıoğlu in Economics, Prof. Dr. Osman M. Karatepe in Marketing, Prof. Dr. Nazım I. Mahmudov in Mathematics, Prof. Dr. Hasan Kömürcügil and Prof. Dr. Osman Kükrer in Electric and Electronics Engineering, and Prof. Dr. Benedek Nagy in Information Technologies. In addition to the academic staff members who are in 2020 list, Prof. Dr. Hasan Demirel, Prof. Dr. Mehmet

Balcılar, Prof. Dr. İzzet Sakallı, Prof. Dr. Müberra Koşar, Assoc. Prof. Dr. Ali Övgün, Dr. Akeem Oladipo are also listed in 2019 study conducted in 2019 which analyzed 22 departments and 176 sub-disciplines. Therefore, total of 12 EMU academic staff members are listed among the world's most influential 160 thousand scientists.

Eastern Mediterranean University (EMU) Faculty of Business and Economics, Department of Economics Chair Prof. Dr. Mehmet Balcılar appears among the most influential researchers in the ranking of "Research Papers in Economics (RePEc)", which is considered to be the world's most important publication and researcher database in the field of economics.

Having been ranked 163rd in the said ranking, Prof. Dr. Mehmet Balcılar appeared in the 0.27% segment according to the publications within the last ten years.

The list featuring the ranking of the registered departments and researchers on the IDEAS site of RePEc, which has more than 60 thousand registered members as of 24 September 2020 is considered to be the most important ranking in the field of economics. Taking into account all years, Prof. Dr. Balcılar ranks 1504th and appears within the top 2,5%

Recently, EMU Faculty of Arts and Sciences Dean Prof. Dr. Mehmet Ali Özarslan, Vice Dean of Faculty of Business and Economics Prof. Dr. Mustafa Ismihan and Chair of Banking and Finance Department Prof. Dr. Nesrin Özataç paid a visit to the Turkish Republic of Northern Cyprus (TRNC) Insurance and Reassurance Companies Association.

#### Prof. Dr. Özarslan Made a Presentation

At the said visit, Association President Raif Çukurovalı, Vice President Börte Barlasoğlu, Board Members Kutlu Yorucu, Zafer Dalka, Secretary General İbrahim Kavçın and Deputy Secretary Halide Devir Fıratlı were present. President of the said association Raif Çukurovalı expressed his satisfaction with the visit and gave information about the latest situation of the TRNC insurance sector. EMU Faculty of Arts and Sciences Dean Prof. Dr. Mehmet Ali Özarslan made a presentation about the Actuarial Program at the meeting.

#### **Further Collaboration to be Established**

At the meeting, the existing cooperation issues within the framework of the existing protocol between EMU and the

TRNC Insurance and Reassurance Companies Association were discussed and decisions were made to further develop the cooperation. In the agenda of the meeting, which was very productive, the issue of enactment of the Actuarial by-law was also discussed. The parties decided to hold a meeting at EMU in October to strengthen their cooperation.

#### **Unique in TRNC**

The Actuarial Science Program offered by EMU Faculty of Arts and Sciences is the only Actuarial Science Program in the TRNC to have been approved by the Council of Higher Education (YÖK). The Actuarial Science Program demonstrates its strength both in terms of quality and quantity, as it is also the only program that provides education in English, including the universities of Turkey. At the same time, students studying in related departments in the scope of the partnership of EMU Mathematics Department and Banking and Finance Departments also have the opportunity to receive a Double Major diploma by studying in Actuarial Sciences - Finance and Banking Double Major Program or Actuarial Sciences - Mathematics and Computer Sciences Double Major programs. During the present day, when Actuarial Science is continuously gaining more and more importance around the world, EMU continues to strengthen its academic staff with the leading faculty members of the field. Establishing a workshop in the near future in line with the aim of furthering the cooperation between the Academy and the Insurance sector was also among the points targeted at the meeting.

## EMU-GIMER BECOMES ENTREPRENEURSHIP AND INCUBATION PROGRAM COORDINATOR



Within the scope of the Foreign Economic Relations Board of Turkey (DEİK) – TRNC Business Council works, the leadership of DEİK and Turkish Cypriot Chamber of Commerce (KTTO), the İTU-TRNC İTU Graduates Union North Cyprus support and within the collaboration between the Eastern Mediterranean University Entrepreneurship and Innovation Center (EMU-GIMER) and the ITU ARI Teknokent, an Innovative Entrepreneurship and Incubation Program has been launched. The program aims to strengthen the entrepreneurship ecosystem in TRNC, creating opportunities for commercializing innovative products and ideas and, contributing the process of being in international markets.

The last day of application for the project, which addresses university students, graduates and other entrepreneurs who are within the 18-40 age group and who have technological and innovative business ideas, has been announced as the 18th of October, 2021. #### The Doors of a Successful Enterprise Will Open

The program is comprised of four stages. The entrepreneurial groups that are accepted to the program will be able to get training on weekday evenings and weekends during the first stage of the ITU Core Entrepreneurship Training. Then during the second stage of the program which is called as Erecting Engineer Meetings, the participants of the program will be provided training on tips regarding how to improve themselves in the entrepreneurship field. Over 300 erecting engineers who are experienced and familiar with the talents, capacity and goals of the entrepreneurs will voluntarily participate during the second stage.

Investor Meetings, which is the third stage, will bring the entrepreneurs together with investors, enabling the entrepreneurs to be the focus of the funds. During the final stage of the program, entrepreneur who are successful will earn the right to participate in the ITU Core Big Bang competition where the participants can win prize money up to 52 million TI

EMU-GIMER Director Prof. Dr. Mustafa Tümer made a statement regarding the topic, saying that participating in a project which holds an important place for TRNC is exciting. Added that, EMU Entrepreneurship and Innovation Center will be contributing to the project in the best way.

Prof. Dr. Tümer pointed out that the service to be provided will be an important touchstone in opening up to the world and that the project's openness to students of all nationalities will make a great contribution to our students in the globalizing world and will add a further impetus to our place in the world.

#### "Customers Can Make Choices"

The young entrepreneurs stated that they aim to develop a 100% safe online taxi application system. Burak Bilgen said "The member taxis in the application can be categorised according to the regions they serve. On the basis of the region, the users will be able to see the taxi drivers licensed to enter the South Cyprus, Closed Maraş Military Area or Ercan Airport within the application and choose the right taxi service, accordingly.

#### "To Be Put into Practice in Different Cities"

Burak Bilgen's statement continues as follows: "The application, which has recently been put into use in all application centers after having completed the piloting work in our city of Famagusta, currently only serves Famagusta residents. The application, which will be actived in other cities of our country as soon as possible, has already attracted the attention of angel investors. Over time, we



are planning to offer this application in Turkey's other smaller provinces. Our biggest dream is to realize bigger projects that will set a precedent for the youth of our country. We are improving our systems in the light of the academic information we have received from EMU and the information we have obtained from our esteemed instructors. #### Who is EMU Graduate Dr. Mehmet Muş?



## BANKING AND FINANCE DEPARTMENT HELD THE 5th INTERNATIONAL BANKING AND FINANCE PERSPECTIVES CONFERENCE (20-22 April 2021)

Eastern Mediterranean University (EMU) Business and Economics Faculty, Banking and Finance Department held the "5th International Conference on Banking and Finance Perspectives" in cooperation with University of Bedforshire and with the contributions of Central Bank of Turkish Republic of Northern Cyprus (TRNC). Held online, the conference attracted the participation of around 120 banking and finance specialists from 15 different countries. The opening speech of the conference was delivered by EMU Rector Prof. Dr. Aykut Hocanın. Prof. Dr. Aykut Hocanın expressed his wish that the important academic studies conducted within the scope of the conference would contribute to the field and thanked the banking, finance and economics experts who attended the conference. Prof. Dr. Aykut Hocanın also thanked the conference organising committee chair Prof. Dr. Nesrin Özataç and the members of the said committee.

#### 45 Papers were Presented

At the conference, which started after the opening speeches, Prof. Dr. Sabri Boubaker from France delivered a presentation titled "The Role of Block Owners in Corporate Governance" and Dr. Ourania Dimitriaki from the U.K. made a presentation titled "Economic Policy Challenges After Covid-19". 45 papers were presented by academicians from different countries within the scope of the conference. In the conference, in addition to the effective monetary policies that central banks should apply in times of volatility in the economy in general and financial markets in particular, issues such as the effects of Covid-19 on banking and economy, volatility models, the importance of surveillance and control, Islamic banking, micro finance and capital markets, corporate finance, economic development and energy economy were also discussed.






#### Data, Findings and Recommendations were Discussed

A panel titled "Turkey's New Policy in Cyprus and Global Regional Balances" was held with the cooperation of Eastern Mediterranean University Cyprus Policy Center (EMU CPC), Euro Politics Magazine and Eastern Mediterranean Policy Association and the main sponsorship of Merit International Hotels. Participating at the said panel held in Kyrenia on Friday, 13 August, 2021 were the Former Prime Minister of the Turkish Republic of Northern Cyprus (TRNC) Ferdi Sabit Soyer, National Unity Party Nicosia Deputy Hasan Taçoy, the People's Party President and Nicosia Deputy Prof. Dr. Kudret Özersay, Retired Ambassador Daryal Batıbay, EMU CPC President Prof. Dr. Ahmet Sözen and Dialogue Media Group Editor-in-Chief Reşat Akar.



#### Turkey's return to the two-state solution policy

EMU CPC President Prof. Dr. Ahmet Sözen emphasized that the uncompromising stance of the Greek Cypriot side was effective in Turkey's return to the two-state solution policy. Prof. Dr. Sözen stated that he was not sure whether this policy change was really a break from the traditional Turkish foreign policy or was part of a tactical strategy that would force the Greek Cypriot side to a bi-communal federation, and that he thought the timing of the new policy was made at the most wrong time, considering Turkey's image in the international community.

Former Prime Minister of the TRNC Ferdi Sabit Soyer stated that for the first time in history, with the 1960 Cyprus Republic Treaties, the Turkish Cypriot people were given an equal social status in the future of the island, and Turkey was given a position with the right to be a guarantor in determining the future of a geography outside the borders of the National Pact after the National War of Independence. Soyer said that Turkey is the guarantor of the island's territorial integrity and constitutional order, and that it is not clear where it will stop if it starts to ignore these principles, and that it has already taken the United Nations (UN) against it.

National Unity Party Nicosia Deputy Hasan Taçoy reminded that today a new opening is mentioned, and in fact it is not new, and that the joint declaration of 11 February 2014 includes the transition to single sovereignty and single citizenship formed by the emerging sovereignty of the Turkish Cypriot State and the Greek Cypriot State. Taçoy stated that the Greek Cypriot administration will never accept the disruption of an administration governed by the Greek Cypriot side alone in any way and make the Turkish Cypriot people partners in the rotating presidential system.

#### The Impasse

People's Party Nicosia Deputy Prof. Dr. Kudret Özersay pointed out that from 1968 to date, all diplomatic methods with different techniques and in different places have been tried and exhausted with the participation of leaders from different political views. Prof. Dr. Özersay said that the Greek Cypriot political leadership said that they were ready to discuss a different solution with their own opinion and that the UN could say "If you have a different solution proposal, let's talk" for the first time, but that the Turkish side does not consider the status that can be achieved with a solution as a precondition.

Reşat Akar, Diyalog Media Group Editor-in-Chief, stated that Turkey's policies regarding Cyprus are unstable, that



the Turkish Cypriot Federated State, which was established in 1975, was not seen as a separatist anywhere in the world, and that the 1977 and 1979 Peak Agreements could be signed because of this. Akar went on to state that with these agreements, the solution of Varosha problem has been considered as a priority, while today's discussions focusing on whether Varosha is Varosha Foundation property are actually self-deception and an attitude towards domestic politics.

Retired Ambassador Daryal Batıbay said that the political inequality that emerged in Cyprus in 1963 has grown stronger against the Turkish side. Batıbay said that while the Greek Cypriot side entered the European Union on behalf of Cyprus, the increase in Turkey's problems with the West and its regional isolation provided a wide area of action for the Greek side, and that instead of talking about the federation, the Greek Cypriot side is trying to transform the Cyprus to a problem not between the two communit ies on the island, but a problem of the Turkish side with the West. He added that the Greek Cypriot side also tries to maintain this status quo that works in their favor.

#### Varosha Issue

EMU CPC President Prof. Dr. Ahmet Sözen mentioned that it is possible to solve the Varosha issue with a comprehensive solution, under the umbrella of the UN, with UN resolutions or by effectively running the Immovable Property Commission, without taking the cases to the European Court of Human Rights. Prof. Dr. Sözen stated that he believes that a comprehensive package containing the opening of Varosha, direct flights to Turkish Cypriots, hydrocarbons and the opening of Turkey's sea and airports to the Greek Cypriot side will contribute to the solution.

Former TRNC Prime Minister Ferdi Sabit Soyer said that the main magic word is a mutually acceptable solution model that depends on UN parameters, includes political equality and two constituent states with two re-

gions. Soyer pointed out that the Varosha issue should be handled in a coordinated manner with the UN, through respecting international law. The status and legal security of the people who will come here and operate their properties, how they will participate in the administration and which administration mechanism they will depend on should be well planned.

Pointing out that an example of the Varosha issue is the lawsuits filed against foundation properties in Egypt, National Unity Party Nicosia Deputy Hasan Taçoy said that it is essential to open this place both in order to return back the rights to those who lost their rights and to ensure economic developments.

Taçoy said that this opportunity provided to individuals should be taken one step further and their rights should be made more applicable, more visible and more livable. Highlighting the fact that instead of an approach that categorically rejects any other form of partnership, a description of cooperation without harming the status of the parties to each other can be a much more realistic and much more applicable model, People's Party Nicosia Deputy Prof. Dr. Kudret Özersay said that this cooperation model can be shaped, for example, through an international unofficial natural gas conference or international companies. Prof. Dr. Özersay stated that he thinks that such a

cooperation will lead to the formation of trust over time and that it can lead to an evolutionary partnership.

Dialogue Media Group Editor-in-Chief Reşat Akar, on the other hand, stated that despite the Summut Agreements, which stated that neither ENOSIS (annexation to Greece) nor a partition to Turkey is possible, a solution has not been reached, due to the fact that both parties actually evaluate the solution in their own internal fronts in line with their political interests. Akar said that he can see what we are experiencing right now, that the policy of playing to the inner tribunes was a blow against us, and that in fact, Turkey needs to develop policies that would compel the Greeks to a federal solution.

Retired Ambassador Daryal Batıbay questioned whether "We can change the status quo with unilateral behavior or not?". Batıbay said that the Immovable Property Commission should be used to Turkify and expropriate Greekowned properties, that Maraş should be transferred to the Commission by removing it from being a military zone under Turkish rule, and that Maronites should be allowed to return to their villages.

Batıbay drew attention to the need for a short-term, nonopen-ended negotiation process in which the restrictions on the Turkish side will be lifted if there is no compromise.



#### PANEL ON 'WAR, PEACE AND STATE BUILDING' organized by Political Science and International Relations Departments of EMU and Wien University and Eastern Mediterranean University Cyprus Policy Center (EMU-CPC) (21 September 2021)



Eastern Mediterranean University Cyprus Policy Center (EMU-CPC) and EMU Business and Economics Faculty Political Science and International Relations Department organized a discussion panel in collaboration with University of Vienna, Austria. The panel took place on Tuesday, the 21st of September, 2021 at EMU with its theme being "War, Peace and State Building". EMU-CPC Chairman Prof. Dr. Ahmet Sözen and, Prof. Dr. Irene Etzersdorfer and Dr. Mag. Ralph Janik from University of Vienna attended the event as speakers.

Following the introducing sessions of the speechmakers to the audience, Prof. Dr. Sözen delivered the opening speech of the panel and made a historical assessment of the Cyprus talks that were held on different grounds and places with various diplomatic methods and political leaders. Stating that the Switzerland meeting in 2016 holds a crucial role as a turning point, Prof. Dr. Sözen said that non-federation solutions came to the agenda due to South Cyprus not being ready to move further. Moreover, Prof. Dr. Sözen added that he was not sure whether Turkey was uncompromising in its two-state solution thesis or was trying to persuade the Greek side to a bi-communal and bi-zonal federation.

Following Prof. Dr. Sözen's speech, Prof. Dr. Etzersdorfer argued that political aims and objectives are a distinctive fea-



ture of war, and that this character of war actually distinguishes it from other individually targeted criminal acts, traditionally viewed as a continuation of policy, i.e. one state to persuade or compel another state to act in accordance with its own choices. Prof. DR. Etzersdorfer also stated that it means using some violent means. Referring to the emergence of the United Nations Convention and the concepts of international society in 1945 and the prohibition of interstate war, Prof. Dr. Etzersdorfer explained that because of this transformation in the political organization of the international structure, interstate wars can no longer be used as a continuation of politics, but this time many civil wars have emerged.

Taking over after Prof. Dr. Etzersdorfer, Dr. Janik interpreted this transformation in the nature of wars at the level of international law. Emphasizing the importance of this transformation, which brings with it transnational events that concern the whole world, such as refugee flows, Dr. Janik said that the legal regulations regarding civil wars and unmanned aerial vehicles are incomplete, the underlying reason is that international law does not regulate non-state wars, that it may take decades for the international community to come to an agreement on the definition of civil wars and adapt it to international law in a way that it can regulate civil wars.

# SEMINAR ON RUSSIAN-TURKISH RELATIONS AND THE PERSISTENCE OF ECONOMIC DEVELOPMENT SINCE THE GREAT WAR (13 October 2021)

Eastern Mediterranean University (EMU) Cyprus Policy Center (KPM) in collaboration with Political Science and International Relations Department organized a seminar on Turkish-Russian relations.

While a limited number of participants were admitted to the event within the framework of the pandemic rules, simultaneous online participation was also provided to the seminar held at EMU.

The said seminar hosted Bilkent University, Department of International Relations academic staff member and Bilkent Russian Studies Center Chair Assist. Prof.Dr. Onur İşçi, who made a presentation on "Russian - Turkish Relations and the Persistence of Economic Development since the Great War, 1921-2021".

EMU Political Science and International Relations Department and Cyprus Policy Center President Prof. Dr. Ahmet Sözen thanked Assist. Prof. Dr. Onur İşçi for his participation and reported that İşçi's work focuses on the history of relations between Turkey and Russia after the last period of the Empire.

Assist. Prof. Dr. Onur İşçi International Relations

Onur İşçi is assistant professor of University in Ankara, Turkey and the his Ph.D. from Georgetown University with distinction in 2014. Dr. İşçi specializes on the histories of Russia, Turkey and the two countries' relationship from the late imperial period to the present day Dr. İsci is the author of various articles that appeared in leading journals, including Diplomatic History, Kritika and Foreign Affairs. His first book, Turkey and the Soviet Union during World War II, was His second book (in Turkish), İmparatorluğu'nun Çöküşü, was published in 2020 by Kronik. He is currently working on a new book project that explores the Politics of Economic Development and Foreign Relations during the Global Cold War

In his presentation, while evaluating the last 100 years of the Turkish-Russian relations with an economic perspective, Assist. Prof. Dr. İşçi focused on cooperation on economic development during the cold war period.

Stating that the open hostility between the Soviet Union and Turkey at the end of the Second World War led historians to ignore much evidence of cooperation and evaluate the two as ruthless enemies, Asst. Prof. Dr. İşçi put forth that in fact, the mutual relations belonging to the classical development scheme of the cold war have also characterized Russian-Turkish relations for most of the last century.

Assist. Prof. Dr. İşçi stated that long before the Soviet Union and the United States of America entered into competition with each other, Moscow extended a helping hand to the Turkish revolutionaries who opposed the conditions of the post-World War I order, just like the Russian revolutionaries.

Emphasizing that the Soviet military and financial aid between 1920 and 1922 helped the Turkish revolutionaries defeat the European occupation armies, Asst. Prof. Dr. İşçi added that in the 1930s, Moscow sent equipment and engineers to build two textile factories, which were the basis of Turkey's five-year development plan, the first development plan implemented by another country with Soviet advice.

Stating that the tension between Moscow and Ankara at the end of the Second World War have never been fully resolved, Assist. Prof. Dr. İşçi said that in the ten years following the end of the war, the two sides began to control the political conflict between them in the name of economic cooperation.

Pointing out that Moscow helped Turkey to industrialize even though it was a member of the opposing bloc even during the escalation of the cold war, Assist. Prof. Dr. İşçi pointed out that in the 1980s and 1990s, both states limited investments in the heavy industry sector, while creating a new era in the Black Sea with gas pipelines






and joint construction projects. Describing this as a new addictive relationship, Assist. Prof. Dr. İşçi emphasized that the pursuit of Western-like modernization is the defining feature of the Russian-Turkish relations in the past century.

#### PANEL DISCUSSION ON DEVELOPMENTS IN THE 'EASTERN MEDITERRANEAN AND CYPRUS POLITICS' (20 OCTOBER 2021)

A conference on developments in Cyprus and the Eastern Mediterranean region was held in cooperation with the Eastern Mediterranean University Cyprus Policy Center (EMU CPC) and the Department of Political Science and International Relations. The conference, which consisted of a workshop panel and a discussion panel, was moderated by EMU academic staff member Assist. Prof. Dr. Aylin Gürzel. Ankara Yıldırım Beyazıt University (AYBU) Head of International Relations Department Prof. Dr. Girav Sadık. Peace Research Institute of Oslo (PRIO) Cyprus Center Senior Researcher Mete Hatay, Middle East Technical University (METU) academic staff member Assist. Prof. Dr. Hayriye Kahveci and EMU academic staff member Dr. ipek Borman made presentations at the said event. Both panels of the conference held at EMU were also offered in an online format.



Speaking at the conference, Prof. Dr. Sadık stated that the international threats arising from the Syrian war has shown how interdependent the security of the European Union (EU) and the North Atlantic Treaty Organization (NATO) is with the security of Turkey. Pointing out that Euro-Atlantic cooperation is needed more than ever in the mass influx of refugees, border security and the fight against terrorism, Prof. Dr. Sadık stated that for an effective cooperation, a real partnership and intelligence sharing are needed between the EU and NATO. Prof. Dr. Sadık also emphasized that no discrimination should be made against NATO allies that are not members of the EU, such as Turkey.

#### "Harsh Policies"

Senior Researcher Hatay said that during the AKP's first decade in power, Turkey sought to transform the country into a global player by spreading its soft power in the Western Balkans, Southeastern Europe, Southern Caucasus and the Middle East. Hatay stated that Turkey, which experienced an unprecedented economic growth during this period, has become a hope for many people in these regions. However, in the ongoing process, Hatay







pointed out that events such as the Arab Spring, Gezi Park demonstrations, problems with Fethullah Gülen, coup attempt and regime change have increased the AKP's need for the votes of groups such as the MHP in domestic politics and caused it to reshape its policies. He stated that soft power policies have been replaced by rather harsh policies.

### "Natural Gas Discoveries Led to Regional Geopolitical Changes"

Assist. Prof. Dr. Kahveci stated that the natural gas discoveries off the Eastern Mediterranean caused regional geopolitical changes. Stating that the Greek Cypriot Administration's hydrocarbon exploration activities in the last ten years and its attempt to use the issue as a pressure tool in the negotiations, the negotiations have become difficult, Assist. Prof. Dr. Kahveci mentioned that Turkey and the TRNC had previously acted on the principle of reciprocity, but after the Crans Montana talks failed, a more proactive Turkish foreign policy has been observed. Assist. Prof. Dr. Kahveci pointed out that the

international community does not have a concrete policy in the region, and drew attention to the negative effects of the Arab Spring, the Syrian war and the lack of regional power on the Cyprus problem.

"Reconciliation and Trust Must Be Built"

Dr. Borman stated that especially in the past 10 years, the Eastern Mediterranean has turned into a regional security complex, which means security dilemmas concentrated in certain geographical areas. Stating that the hydrocarbon issue and the acceptance of Cyprus, which the Greek Cypriots unilaterally represent, to the European Union played an important role in this process. Dr. Borman also pointed out that the developments in the Eastern Mediterranean were articulated with the established political discourses and social insecurities in Cyprus. Dr. Borman said that the security dilemma in Cyprus should be revisited in terms of reconciliation and trust building, so that we can imagine a Cyprus beyond realpolitics and today's Cyprus. Dr. Borman claimed that these processes are the key in transforming the two communities on the island into a pluralistic one.

Three universities in total made it to the list across the island of Cyprus, while EMU has appeared in the top band among these universities. Among the said universities, the second ranked university is in the 501-600 band.

EMU Faculty of Business and Economics has the unique quality of appearing as the only faculty from the island of Cyprus in the field of Economic Sciences in the ShanghaiRanking World Universities Academic Ranking 2021. Among Turkish universities, only Koç University, Bilkent University and EMU made it to the list.

At the same time, EMU Faculty of Business and Economics academic staff members Prof. Dr. Salih Katırcıoğlu and Prof. Dr. Mehmet Balcılar have successfully appeared on the list of the most influential scientists in the world. In the study conducted by the USA Stanford University and published in the journal PlosBiology, Faculty of Business and Economics, Department of Banking and Finance academic staff member Prof. Dr. Salih Katırcıoğlu is in the top 2% of the world's most influential scientists in the one-year impact (2019) and career-long impact categories. In the said ranking, Faculty of Business and Economics, Economics Department Chair Prof. Dr. Mehmet Balcılar, on the other hand,


appears in the 2% of the world's most influential scientists in the one-year impact (2019) category.
