After signing a Memorandum of Understanding between Adam Mickiewicz University in Poznan (Poland) and EMU, developing a collaboration agreement between Department of Political Science and International Relations and Faculty of Political Science and Journalism have started.

In an attempt to increase admission in our Faculty, we hosted a pre-admission orientation in June for TRNC students who passed the EMU entrance exam.

Our Faculty was the venue for two successful conferences in Spring 2019.

The Banking and Finance Department organized the 4th ICBPF Conference in 2019 in collaboration with Montpellier Business School, France. 120 papers were submitted to ICBPF 2019 form 24 countries. Full text articles are published in Springer Proceedings in Business and Economics entitled Global Issues in Banking and Finance.

In June 2019, the Economics Department hosted the 11th International Conference on Euroasian Economies in collaboration with Beykent University, Turkey and Manas University, Kyrgyzstan.

The conference aims to bring together academicians and decision makers involved in research about Eurasian countries in a forum to discuss current and future economic and social issues of the region.

Eduniversal, the global ranking and rating agency specializing in higher education featured 3 master's programs of our Faculty amongst the top 200 postgraduate programs in a report they prepared for 2019. In the Eduniversal 2019 report, Energy Economics and Finance program, jointly offered by the Departments of Economics, and Banking and Finance was ranked 4th in Eurasia and the Middle East in the category of Energy and Natural Resources. In addition, the Banking and Finance postgraduate program was ranked 9th in Eurasia and the Middle East in the category of Corporate Finance. Finally, the Economics postgraduate program was ranked 10th in Eurasia and the Middle East in the category of Economics. Last but not least, ShanghaiRanking, an independent organisation which has been the official publisher of the Academic Ranking of World Universities since 2009, Eastern Mediterranean University appears within the 301-400 band in the Economics Category.

The achievements of our faculty, staff, and students have continually demonstrated our dedication to teaching, research and community service. I hope you enjoy reading this issue of FBE Newsletter and that your motivation will improve as you read about these success stories. As Dean, I aim to create an environment that would enable every member of our Faculty to fulfill their potential. Thorsten Beck is professor of banking and finance at Cass Business School in London. He is also a research fellow of the Centre for Economic Policy Research (CEPR) and the CESifo. Previously he worked in the research department of the World Bank and has also worked as consultant for – among others - the European Central Bank, the Bank of England, the BIS, the IMF, the European Commission, and the German Development Corporation. His recent research interest is access to financial services, including SME finance, as well as on the design of regulatory and bank resolution frameworks. In addition to numerous academic publications in leading economics and finance journals, he has co-authored several policy reports on access to finance, financial systems in Africa and cross-border banking. In addition to presentation at numerous academic conferences, including several keynote addresses, he is invited regularly to policy panels across Europe. He holds a PhD from the University of Virginia and an MA from the University of Tübingen in Germany.

Prof. Dr. Duc Khuong Nguyen holds a MSc and a PhD in Finance from the University of Grenoble Alpes (France) and obtains his HDR (Habilitation for Supervising Doctoral Research) in Management Sciences in June 2009. He also completed the "Leaders in Development" program at Harvard University, John F. Kennedy School of Government, Executive Education (2013). In January 2013, he joined IPAG Business School as Professor of Finance and Deputy Director for Research. He is Subject Editor at Emerging Markets Review, Journal of International Financial Markets, Institutions and Money; Associate Editor at Finance Research Letters, International Review of Financial Analysis, Journal of Forecasting; and Area Editor at Research in International Business and Finance. His principal research areas concern emerging markets finance, energy finance, volatility modeling and risk management in international capital markets. His most recent articles are forthcoming and published in refereed journals such as European Journal of Operational Research, Journal of Eanking and Finance, Journal of Economic Dynamics and Control, Journal of Empirical Finance, Journal of Forecasting, Journal of International Financial Markets, Institutions and Money, Journal of International Money and Finance, Journal of Macroeconomics, Journal of the Operational Research Society, Macroeconomic Dynamics, Quarterly Review of Economics and Finance, Review of International Economics, Review of Quantitative Finance and Accounting, and World Economy. SEMINARS

Political Science and International Relations Department organized three seminars this term



The seminar series started with the presentation of Prof. Dr. Levent Köker on 24 April 2019 with a presentation entitled:

"Populism, Authoritarianism or Dictatorship: Turkish Style Presidentialism in Perspective" at BEA5. Levent Köker has published a lot of articles in Turkish as well as in English including Modernization, Kemalism and Democracy (1990), Two Different Policies (2008) and Democracy, Criticism, and Turkey (2008). In 2007, Köker was part of a team led by Prof. Dr. Ergun Özbudun who prepared a new draft constitution in Turkey. He is currently working on the topics of establishing a constitution, democratic political theory, post-nation-state constitu-

tionalism, and cosmopolitanism. During the seminar, Köker elaborated Turkey switching to the Presidential System as a result of the April 2017 referendum, the "right-wing populism" of the new system and approaches that are important in supporting the development of democracy within the scope of "competitive authoritarianism" or "sectarian management."

On 8 May 2019, Public Affairs Officer of the Embassy of the United States; Glen Davis gave a seminar entitled: "Deep Sate or Deep Debate:

The Process of Making US Policy" at BEA5. Glen Davis currently serves as the Public Affairs Officer at the U.S. Embassy in Nicosia. From 2013-15 he led the Political Team on the Afghanistan desk during the national elections of 2014 and the subsequent political crisis that led to the formation of the government of national unity. From 2011-13, he was the desk officer for public diplomacy in Afghanistan, the primary liaison between Washing among Sri Lankans in the aftermath of the long insurgency that ended in 2009. Before that,



he was vice consul in London. Mr. Davis has received three individual Superior Honor Awards from the State Department and was the Council of American Ambassadors' Katherine Davis Public Diplomacy Fellow for 2012-3. Before joining the Foreign Service in 2006, Mr. Davis enjoyed one career as a teacher of literature and a shorter one as a telecommunications consultant. Born and raised in Massachusetts, he speaks Greek, Italian, French, German, and Sinhala and reads Latin and Ancient Greek. He holds an honors degree in History and Literature from Harvard University, a Master's degree in philosophy from St. John's College in Annapolis, and one in English and Comparative Literature from the University of California at Irvine. ton and post for the largest public diplomacy effort in the State Department. From 2009-11 he worked as Deputy PAO in Colombo, Sri Lanka, where, as a press officer and cultural attaché, he created several programs to foster reconciliation.


Mehmet M. Erginel completed his undergraduate education at Duke University with a major in Economics. By the time he graduated, it was clear that he had to look elsewhere for the answers to the questions he considered most important, as a result of which he turned to philosophy. He received his M.A. and Ph.D. in Philosophy at the University of Texas at Austin, specializing in ancient Greek philosophy. After completing his graduate studies in 2004, he returned home to Cyprus and has been working at the Eastern Mediterranean University

since then. Erginel's research has focused on a variety of topics in the works of Plato and Aristotle, primarily in ethics and moral psychology but also metaphysics and epistemology. His articles have appeared in the leading journals in the field, including Oxford Studies in Ancient Philosophy, The Classical Quarterly, and the British Journal for the History of Philosophy. He has been a Visiting Research Fellow at Princeton University and a Visiting Scholar at the University of St Andrews. He has also taught at the Boğaziçi University Department of Philosophy as Visiting Faculty.


Department of Economics organized three seminars this term

Before being promoted as the Dean of Faculty, he was the head of the Business Administration Department at the Middle East Technical University, Ankara, Turkey.




