Department Overview

Banking and finance is the study of the creation and management of wealth. A banking and finance student learns how to evaluate and control risk. The finance program prepares students for a variety of positions in financial and non-financial enterprises. Career opportunities exist in commercial banking and financial institutions and in the regulatory agencies that oversee them. Additional opportunities exist in corporate finance including positions in financial analysis, cash management, and credit management. Investment-oriented students can explore opportunities in brokerage, bank trust and institution portfolio management. People with degrees in banking and finance have careers as commercial bankers, investment bankers, loan officers, financial analysts, insurance underwriters, stockbrokers, institutional portfolio managers, credit managers, insurance and risk managers, and financial planners. Your time here will also equip you with the research techniques that are vital to postgraduate study. Department of Banking and Finance has modern teaching facilities such as five computer laboratories, internet connections that provide an opportunity for students to follow the latest developments in the world-wide capital

markets. Furthermore, it provides internship facilities to its students in some of the best financial institutions of the region. Through the Programs offered by the Department of Banking and Finance, many international students are provided with many facilities such as "Foreign Students' Club" that enable them to interact with each other and also organize cultural activities. In addition, the "Finance and Stock Exchange Club" which is run by students under the supervision of faculty members, gives students and opportunity to gain experience on financial markets. The Finance and the Stock Exchange Club organizes certificate programs in cooperation with the financial institutions from the financial sector. The department has proven its competence in the field of banking and finance education with the FIBAA (Foundation for International Business Administration Accreditation) accreditation from Germany it received in 2014. Our students get the chance of improving their written and oral communication and individual research skills. In addition to this, in many courses, much of the weight is given to term projects, assignments and practical application of knowledge and skills. We believe, this approach is an advantage for our graduates after their graduation, when they are looking for jobs.

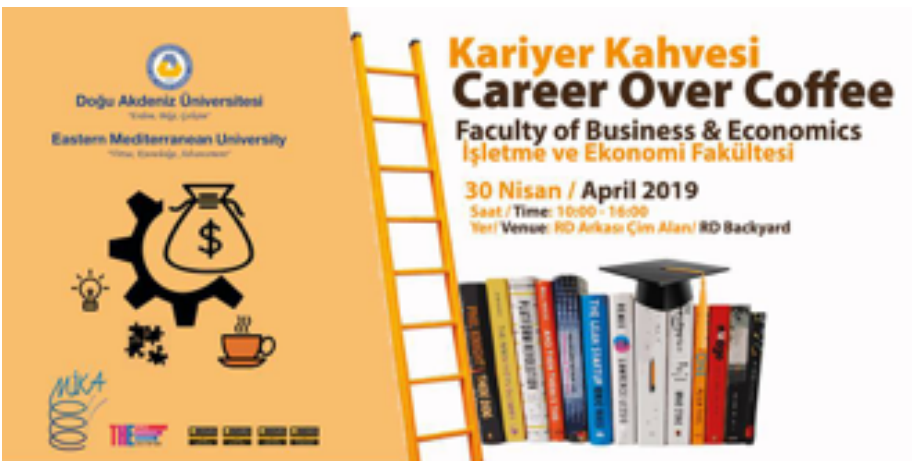

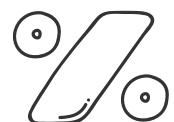
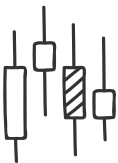
